A written report on the status of the Water & Sewer District was provided by Will Kalin. He emphasized that the replacement of water meter registers will be resuming the last week of July and he plans to have it completer to approximately 90% of all faulty meters by the end of August.

Resolution Approved.

Motion made 1<sup>st</sup> by Logan Eddy and 2<sup>nd</sup> by Clarence Woodruff to approve the 284-B. Ayes: Ken Gleason, Les Berghorn, Logan Eddy, Clarence Woodruff and Gary Eddy. Motion carried.

Gary updated the board on the Percy land on the burnup road. Tim Percy has withdrawn his desire to sell the land to the town, however he would like to ensure that he has access to eventually build a single house. Gary said the the town may likely assist in this. There was much discussion on this with the possibility of the town assisting in regrading from the end of the blacktop to a point that would allow adequate access for Mr. Percy to his land.

Donna spoke on why at least three board members should sign all bills to ensure that any outside entities who may question them can see that a majority of the board has reviewed them.
